IMPACT FEE STUDY  
PRESENTATION

Mr. Randy Young, Henderson, Young and Company, presented the proposed update to the current school Impact Fees. He stated the impact fees being proposed are actually a few dollars less than the current impact fees.

He spoke regarding the following differences between the current impact fee, which was originally calculated by his firm in 2003, and the impact fee being proposed:

1. The impact fee being proposed now addresses the Class Size Amendment, where the preceding impact fee did not.
2. The cost of schools is updated to represent local cost; whereas in 2003 they were using state averages.
3. The cost of land the district pays for school sites is based on appraisals of school sites the district owns, on the basis that future school sites will cost approximately what the market is currently; whereas in 2003 they were using old estimates of land cost.
4. They included in the impact fee, as they did in 2003, a small amount of money for “off-site” costs for things such as turn lanes or drainage improvements. In 2003, there were staff estimates of those costs, however, in this update they are based on actual cost from recent schools. Absent of knowing what the future sites are going to be and knowing what those costs will be, they think this is a defensible approach.
5. The 2003 impact fee calculation had, as required by case law, a revenue credit calculation. They reduced the amount of the impact fee to represent the amount of money the district has available from other sources, net of their other commitments such as maintaining the existing schools.

Mr. Young stated this 2006 Impact Fee Study adheres very specifically to the Judge’s ruling from the previous court case concerning the impact fee done in 2003. The outside Counsel who represented the School Board and the County in this court case have independently reviewed these calculations and have indicated it was permissible for him to share with the Board members that they find this methodology to be consistent with the court’s order.

Mr. Young stated the current impact fee for a single family home is \$9,981.00 and the impact fee being proposed for a single family home is \$9,928.00, which is \$53.00 per house less than the current fee.

Mr. Young reviewed the process from this point to full implementation of this recommendation. He stated the first step would be for the School Board to decide whether or not this impact fee study is acceptable, based on public and stakeholder input, and decide what recommendation to

make to the Board of County Commissioners. The County Commissioners will then schedule a public hearing to receive input from the public regarding the proposed impact fee and then vote to adopt the impact fee, making whatever adjustment they feel necessary based on the school district's recommendation. There will also be an accompanying ordinance which is in the process of being developed.

He stated, for the public's benefit, that the School Board receives and uses the Impact Fees to build schools or portions of schools that serve new development, however, the School Board does not have the legal authority to adopt the impact fee. The fee is actually adopted by the County government.

Mr. Wheeler asked Mr. Young to review the recommendation from the Growth Management Task Force that was discussed at a workshop recently regarding the impact fee study.

Mr. Young stated the Growth Management Task Force had inquired about how the school district dealt with the donation of land for school sites. The way donations are handled currently, which is also the basis of the impact fee study that they prepared, assumes that people have donated sites to the school district which they have gladly accepted, but for which there is no direct credit to the person donating the site. Instead, their study analyzes how much donations the district has received in the past and builds into the impact fee calculation a reduction of the fee so that all impact fee payers get a reduction for the donated sites, whether they donate them or not. The Growth Management Task Force asked if it was possible to calculate what the fee would be if that policy was different. That is, if everyone paid for the full cost of the land and then the property owners who made the donation would receive a credit for their donation, but everyone else would not. He stated they performed that calculation, which would be approximately a \$500 increase to the impact fee being recommended.

Mr. Larry Walter, with Hansen, Walter and Associates and Chairman of the Growth Management Task Force for the Osceola/Kissimmee Chamber of Commerce, stated it was important to the Growth Management Task Force that the impact fee be distributed fairly. He spoke regarding the appraisals that were done on the cost of land for elementary, middle and high schools. After reviewing that information, the task force felt the recommendation did not make the playing field level for each one of the developers. He stated the recommendation from the task force would not prohibit developers from donating property to the school district, however, anyone who goes to that school, who may or may not be outside that property, that is paying impact fees are not paying a fair share for the cost of the land that was there.

Mr. Walter stated the recommendation from the task force was that they take out the discount for the land value, add 100% of the land cost into the impact fee, make that calculation and then make that recommendation to the County Commission.

Mr. Walter stated their second recommendation was that the school district perform annual updates on the impact fee, like they have also recommended to the County on the transportation impact fee.

Mr. Joseph Volpe, representing the Osceola Chapter of the Home Builders Association, stated they concurred with the statement and supported the recommendations made by Mr. Walter and the Growth Management Task Force to revise the school impact fee methodology. He stated the calculation being done will be the same, but instead of assuming there is a donation the district will be giving credit for the actual donation which will go to the individual making the donation.

Mr. Volpe entered into the record correspondence from the Home Builders Association's consultant which included a list of technical questions for the School District and their impact fee consultant.

Chairman Chalifoux asked what the dollar amount would be if the calculation was made according to the recommendation made by the Growth Management Task Force.

Mr. Young made a clarification, for the record, that his study calculated what percentage of the land the school district has received as donations in recent years and what percentage the district purchased. He thought he heard Mr. Walter say, at one point, that the fee was reduced by 40% and he thought what Mr. Walter intended to say was that the land portion of the fee was reduced by 40%. He did not want anyone to think that they were contemplating a 40% reduction from the \$9,000 fee.

Mr. Walter agreed with Mr. Young's statement.

Mr. Young stated the impact fee being recommended for a single family is \$9,928.00. If the land acquisition policy was changed by the Board, according to the recommendation made by the Growth Management Task Force, so that they did not reduce the land portion of the impact fee by 40% of the land they get donated, and instead they included the assumed cost for everyone and only the person giving the land would get a credit, the new impact fee for a single family home would be \$10,441.00, which is a difference of \$513.00.

Mr. Young presented the following break down of the cost differences:

Mr. Wheeler asked Mr. Volpe what recommendation the Home Builders Association could support without taking anyone to court.

Mr. Volpe stated the Home Builders Association authorized him to say that they supported the Growth Management Task Force's recommendation. He also stated it was very important that there be a more accurate and more current updating of the impact fee studies.

Mr. Wheeler asked if the Home Builders Association would not sue the County Commission if they decided to use the impact amount for a single family home of \$10,441.00.

Mr. Volpe stated to his knowledge they would not.

Chairman Chalifoux asked Mr. Young what the advantages and disadvantages would be to the School Board if they decided on the additional \$513.00 for single family homes.

Mr. Young gave a brief presentation of the pros and cons from the perspective of the School board regarding the two policy options the Board faces.

Mr. Greer presented a hypothetical situation where a developer is building 3,000 units and they are planning to donate a 20 acre site for an elementary school. He asked if they would get full impact fee credits for that donation.

Mr. Young stated that under the current policy they would not, however, they would under the task force's recommendation.

Mr. Walter stated they would only get impact fee credits for the land portion.

Mr. Young stated if the land they were donating is worth more than the land portion of the impact fee, according to what he has been hearing during the discussion, the credit would be limited to the land portion that they calculated. Any excess value would be a tax benefit to the donor, but not a cost to the district.

Mr. Greer then asked, hypothetically, if a developer is building 3,000 units on one side of the county and three years later they want to build 3,000 more units on the opposite side of the county, can they take those impact fee credits over there and not pay any impact fees on the land over here, or does it have to be used in the development.

Mr. Young stated that was a terrific question, however, they do not have an answer based in law. It would be based in the School Board's policy. He suggested, if they are interested in taking the task force's idea any further, they direct staff to discuss it further with the Growth Management Task Force to get more details.

Mr. Greer stated he would like to get more details in order to understand what they are asking because he could potentially see these credits getting spread out and down the road not being able to afford to build the school.

Mr. McKay agreed that they need to know more details on how this will be approached long term. He stated they need a timetable on when Mr. Young can meet with the Home Builders Association and Growth Management Task Force and come back to the Board with more information.

Mr. Young stated he would be in town again next week and he would talk to staff and those two groups to try and find a mutually agreeable date to have that discussion.

		Mr. Stone used Mr. Greer’s hypothetical situation to show there could be a potential issue concerning the density of the land and stated there needs to be some premise under which they arrive at a dollar value. He asked that the issue of density and what happens if the density changes after they have paid for the land be addressed during these discussions as well.
